**BACKGROUND:** If you recall we brought forward a proposal to assist some of the other Municipalities within Lacombe County with their street sweeping. Neither the Village of Alix nor the Village of Clive have their own street sweepers. Last year both Villages contracted our services. Council passed a motion to provide street sweeping services to our urban municipal neighbors, on a trial basis in 2021 at a rate of \$175.00 per working hour.



**DISCUSSION/ALTERNATIVES:** Last year we spent five or six days sweeping, which include travel to and from each municipality. Both the Village of Alix and the Village of Clive have requested our street sweeping services again this year.

As we noted last year, the rates in this guide are supposed to take in the use of the machine, fuel & lube, the cost of the operator and a profit for the equipment owner. Our street sweeper would list out at \$206.00 per hour. It is our intent to assist our urban neighbors and charge a reasonable rate, that more than likely would not include a large profit. We would again propose to charge a 15% discounted rate of \$175.00 per hour.

**IMPACT ON BUDGET:** We would likely net \$8,000 to \$10,000 for both villages.

**RECOMMENDED ACTION:** That the following motion be presented for consideration:

**“That the Town of Eckville provide street sweeping services to our Urban Municipal Neighbors, on a discounted rate of \$175.00 per working hour.”**

**BACKGROUND:** Our most recent listing with Sandi Hallgren of REMAX Realty expired on December 31, 2021. Both our McDonald Heights and our Westview lots were included in the listing. Our rationale for ending the listings at the end of 2021 was to allow our New Council to have input in the future sale of our lots.

**DISCUSSION/ALTERNATIVES:** Administration is recommending that we handle our lot sales a bit differently this year. In the past we have found that most of our contacts regarding the Westview Manufactured Home Subdivision have come through direct calls to our office or through Manufactured Home Sales Companies. So, from our point of view we could pass on listing these lots.

McDonald Heights is a bit of both, some who contact our office and some from realtors. There is the belief that we should have our lots on MLS, but maybe we could wing it for a year or so!

- We would offer a couple of options.
- One - continue listing both subdivisions.
  - Two – don't list either subdivision.
  - Three - don't list either subdivision but pay a fee to realtors who bring us an offer.
  - Four - list McDonald Height Subdivision only and the Town sells Westview Subdivision.

**IMPACT ON BUDGET:** Not a major impact, however there is a cost associated with paying realtors.



**BYLAW No. 782 - 2022**

**ECKVILLE MEDICAL COMMITTEE BYLAW**

**A Bylaw of the Town of Eckville in the Province of Alberta to Establish the Eckville Medical Committee.**

**WHEREAS** section 145 of the Municipal Government Act allows a council to pass bylaws in relation to the following:

- a) The establishment, functions, and procedures of the Town of Eckville council committees and other bodies; and
- b) Procedures to be followed by Council, council committees and other bodies established by the council.

**AND WHEREAS** The Council of the Town of Eckville is desirous of establishing a committee to assist Council to research the provision and funding of additional medical facilities and medical services of the residents of the Town of Eckville and Surrounding Area.

**NOW THEREFORE** the Council for the Town of Eckville in the Province of Alberta, duly assembled, hereby enacts as follows:

**1. TITLE**

This Bylaw shall be cited as the Eckville Medical Committee Bylaw.

**2. PURPOSE**

The purpose of this bylaw is to create a committee to assist Council with researching the provision and funding of additional medical facilities and medical services for the residents of the Town of Eckville and Surrounding Area.

**3. DEFINITIONS**

- 3.1 "Council" means the duly elected Municipal Council of the Town of Eckville.
- 3.2 "CAO" means the person appointed to the position of Chief Administrative Officer by the Council of the Town of Eckville.
- 3.3 "Committee" means the Eckville Medical Committee.

**4. COMMITTEE STRUCTURE:**

- 4.1 The Eckville Medical Committee Members shall be appointed by Council for a term of one (1) year term.
- 4.2 Appointments shall be made at the final passing of this bylaw and then annually at the town's Organization Meeting.



- 4.3 The Committee shall be comprised of five (5) members as follows:
- a) Three (3) Members of Eckville Town Council: Mayor, Deputy Mayor plus one other Councillor:
  - b) Two (2) Member of the Public:
  - c) The Mayor shall be the Chairman and Deputy Mayor shall be the Vice Chairman:
  - d) The CAO and the Finance & Administration Supervisor shall act in an advisory and support capacity to the Committee:
  - e) The CAO shall ensure that adequate administrative support is provided to assist the Committee as needed:

**5 MEETINGS:**

- 5.1 Meetings will generally be held in the Council Chambers in the Town Office:
- 5.2 Meetings should be held a minimum of four times each year:
- 5.3 Additional meeting shall be held as required, at the call of the Chair.

**6 AUTHORITY:**

- 6.1 The Eckville Medical Committee is an advisory committee and is accountable to the Eckville Town Council.
- 6.2 The Eckville Medical Committee shall research and investigate additional medical facilities and medical services which would improve the overall level of medical care available to the Residents of the Town of Eckville and surrounding area.
- 6.3 The Eckville Medical Committee shall make recommendations to Council regarding the securing and provision of additional medical facilities and medical services which would improve the overall level of medical care available to the Residents of the Town of Eckville and surrounding area.

**7 MISCELLANEOUS**

- 7.1 This Bylaw shall come into full force and effect on the date of passing.

**Current Activities:**

- **Highway 11 Twinning, Functional Planning Study – Highway to Township Road 390 (east of Benalto):** We are still waiting for a meeting date for the next Stakeholders meeting.
- **Water Pump House Upgrade Project:** Our Contractor is more or less finished. The new flow meter for the backwash system had been installed and we are now able to monitor how much water we are using to backwash our greensand filters. Dale Chretien is still working with our Engineers, our Software Programmers and our I T Consultant to make some additional minor programming changes and to complete the set up of a Surface Pro Computer for remote access to the PLC (program logic controller) after hours. We are still pulling together quotes on painting the inside of the water treatment plant building and ordering a new desk and storage cabinets for the office area. We will also be installing some new counters for lab testing and a basic shower to be used in the event of chemical accidents.
- **Pothole Patching:** The Public Works Team started filling potholes on 54<sup>th</sup> Avenue on April 7<sup>th</sup> and will continue as soon as our new supply of road patch material arrives.
- **Street Sweeping:** A notice has been posted on Facebook to let people know that we are starting our spring street sweeping activities. They will be doing a quick round to clean up the worst areas and then we will do a more detailed street by street round. We are hoping to have our streets done in a couple of weeks and, if approved, our Team will be heading out to Alix and Clive to do their street sweeping again this year.

**Future / Planned Activities:**


- **ICS-200 Course:** We are still hoping to have some more of our Staff complete the ICS-200 course this spring. As previously noted, ICS-200 enables personnel to operate efficiently during an incident or event within the command system.
- **Stantec Report on Wastewater Treatment Options:** We finally received a draft copy of the above noted report from Stantec. We will be contacting them shortly with a few questions and if all goes well, we should be able to present it to you on April 25<sup>th</sup>.
- **Structural Inspection of Old Eckville Water Tower:** We finally heard back from Stantec, but we are still waiting for their structural inspection and report. We are not expecting any bad news, but we do want to be reassured that the Tower is still structurally sound and safe.
- **Year End Audit:** The draft financial statements are being reviewed by the auditors. We are on track to present them to Council on April 25<sup>th</sup>.
- **Strategic Planning Discussions:** We hope that everyone found the Strategic Planning Session on April 4<sup>th</sup> to be worthwhile. We hope to have a draft of what you discussed for the April 11<sup>th</sup> council meeting. This will likely be a handout on Monday night.

Management Report – April 11, 2022

- **2022 Operating and Capital Budget:** We are incorporating the guidance received from the Strategic Planning session into our 2022 Operating and Capital Budget and hope to have a document for review by Council at the April 25<sup>th</sup> meeting.
- **Eckville Medical Committee:** We have a draft “Eckville Medical Committee Bylaw” in the April 11<sup>th</sup> agenda package for your review.
- **Nurse Practitioner Project:** Mayor Ebden is working with us on a draft letter that will be sent out, initially, to several local Oil and Gas Companies. We will then work on a plan to approach other businesses and local and surrounding residents for financial support.
- **Municipal Breakfast:** The Municipal Breakfast is scheduled for May 7<sup>th</sup>. Save the date on your calendars.

## HIGHLIGHTS OF THE REGULAR COUNCIL MEETING MARCH 24, 2022

### **TOWN OF ECKVILLE – NURSE PRACTITIONER PROGRAM**

Following a presentation to Council on February 28, 2022, from the Wolf Creek Primary Care Network, a request was made by the Town of Eckville to participate in the Nurse Practitioner Program. The Town of Eckville asked Lacombe County to provide an annual funding contribution of \$33,500 over a three-year term to offset costs required to support a Nurse Practitioner for the Town of Eckville and the surrounding area.

A motion that Lacombe County participate in the Nurse Practitioner Program proposed by the Town of Eckville by contributing \$10,000 in annual funding towards this program for a three-year period did not receive the approval of Council.

### **RC(1) CITY OF LACOMBE**

Council approved resolutions to contribute up to \$175,388 to the City of Lacombe's annual capital projects at the Lacombe Memorial Centre, Kinsmen Aquatic Centre, and Gary Moe Sports Arena. Lacombe County will fund this contribution from the Recreation Capital Assistance Reserve.

In addition, Council approved a contribution of up to \$20,000 toward the City of Lacombe's Columbarium expansion at the Lacombe Fairview Cemetery, which will be funded through the Cemetery Capital Reserve.

### **LACOMBE COUNTY VISION, GOALS & RESULTS**

On March 8 and 9, 2022, Lacombe County Council participated in a Strategic Planning Workshop to develop a new strategic plan for the four-year period of 2022-2025.

With the completion of the workshop, the consultant has now compiled the Draft Vision, Goals and Results developed from the thoughts, ideas and input of Council from the workshop.

Council approved the Vision, Goals and Results as revised, and directed the County Manager to move forward with developing the Lacombe County Strategic Plan 2022 to 2025.

### **POLICE ADVISORY COMMITTEE**

Lacombe County Council voted in favour of becoming a member of the Blackfalds RCMP Detachment/Red Deer County Police Advisory Committee. Reeve Barb Shepherd was appointed as the Lacombe County representative to the Committee, and Councillor Dwayne West was appointed as the alternate.

### **PARKING FEES FOR SUNBREAKER COVE/SANDY POINT**

Council defeated a motion to include a provision in the fee schedule for parking and launching at the Sunbreaker Cove boat launch and Sandy Point Beach and boat launch; that County citizens be exempt from paid parking by providing ratepayers free seasonal parking passes; and that one terminal be available at Sunbreaker Cove boat launch and Sandy Point Beach and boat launch for people who cannot pay for parking with a cell phone.

By resolution of Council, an annual parking pass for the Sunbreaker Cove boat launch and Sandy Point Beach and boat launch will be implemented as follows:

Beach Parking Fees \$ 120  
Boat Launch & Parking Fees \$ 160  
Boat Launch Fees - \$ 80

A motion that an exemption be offered for County ratepayers to allow for a free parking/launching pass for up to two license plates per ratepayer did not receive Council approval.

A motion to amend the above noted resolution to one license plate per ratepayer did not receive Council approval.

### INTRODUCTION:

On March 8, 2022, the Town received correspondence from the Eckville and District Historical Society (EDHS) advising the Town that Eckville's First Hospital had been donated to the EDHS. The correspondence further noted that the donation was conditional upon EDHS being able to operate a museum or a cultural/historical centre from the property.

A copy of this correspondence is attached.

### APPLICATION FOR HISTORICAL MUNICIPAL RESOURCE DESIGNATION:

Attached to the Eckville and District Historical Society's correspondence was a application form for "Historical Municipal Resource Designation". The application requests that the Town of Eckville designate Eckville's First Hospital as a Municipal Historical Resource in accordance with the provisions of the HISTORICAL RESOURCES ACT.

The application notes the location of Eckville's First Hospital as 5204 – 50<sup>th</sup> Street and provides a copy of the title for the property.

The application also provides historical information about Eckville's First Hospital and rational as to why the property should receive a municipal historical resource designation.

A copy of this application is attached.

### DONATION AGREEMENT:

Also attached to the Eckville and District Historical Society's correspondence was a copy of a "Donation Agreement" between the Meridian Heights Investments Ltd. and the Eckville and District Historical Society.

This short agreement provides for the donation of the Eckville's First Hospital property to the Eckville and District Historical Society along with a statement that the Eckville and District Historical Society

wish to preserve and restore the house and operate the house as a museum or cultural/historical centre for Eckville and District.

The actual donation of the property is conditional upon the Eckville and District Historical Society being able to obtain "Municipal Historical Resource Designation" for the Town of Eckville in order that the Eckville and District Historical Society may operate a museum or cultural/historical center from the house and site.

A copy of this agreement is attached.

#### **INSTRUCTION TO ADMINISTRATION:**

Eckville Town Council reviewed the Eckville and District Historical Society's correspondence, application, and donation agreement at their March 14<sup>th</sup> council meeting. After discussing the matter at length, the following motion was presented and passed:

"that administration be instructed to prepare a report outlining the process involved in designating Eckville's First Hospital, located at 5205 – 50 Street, as a 'Municipal Historical Resource' and detailing the possible effects on the Town's future budgets and liabilities."

#### **LEGISLATION:**

THE HISTORICAL RESOURCES ACT is the Provincial legislation which provides for historical resources within the Province of Alberta. A copy of this legislation, last updated on June 2, 2021, is available upon request.

This act is relatively short, containing 54 sections, which provides for the designation of historical resources, the protection, preservation, and maintenance of buildings, structures, and areas of historical significance. The sections dealing with the designation of historical resources are:

- section 20 which provides authority for the appropriate Minister to designate a "Provincial Historical Resource"; and
- section 26 which provides authority for a Council of a Municipality to designate a "Municipal Historical Resource".

#### **PROCESS FOR DESIGNATION:**

- The Town of Eckville would first serve notice to the Owners (Eckville and District Historical Society) of their intent to declare the "Eckville's First Hospital" property as a municipal historical resource.
- Sixty (60) days after serving notice of intent to the Owner, Council may then, by bylaw designate the "Eckville's First Hospital" property to be a "municipal historical resource".
- A copy of the bylaw would then be served on the Owner.
- A certified copy of the bylaw would be registered on the title of the Eckville's First Hospital property at the appropriate Land Titles Office.

**TOWN'S AUTHORITY THROUGH THE BYLAW.**

The "municipal resource designation" bylaw would be effective when it is passed and not withstanding any other act, no person shall:

**Section 26 (6)**

- (a) Destroy, disturb, alter, restore, or repair an historic resource that has been designated under this section, or
- (b) Remove any historic object from an historic resource that has been designated under this section.

Without the written approval of the Council or a Person appointed by the Council for the purpose.

**Section 26 (7)**

The Council or the person appointed by the Council, in its or the appointee's absolute discretion, may refuse to grant an approval under subsection (6) or may make the approval subject to any conditions it or the appointee considers appropriate.

The Council's authority over this "municipal historical resource" stays in place until such time as the appropriate bylaw is repealed.

**FUTURE CONTROL OF THE PROPERTY:**

It should be strongly noted that if the Town proceeds with the designation of the Eckville's First Hospital property as a "municipal historical resource", the Town will then have ultimate authority over the maintenance, repair, alteration, restoration, and preservation of the property, regardless of who owns it.

This could result in the Eckville and District Historical Society being required to check with and receive permission for any maintenance, repair, or alterations before any work was done.


**TOWN'S FUTURE FINANCIAL LIABILITIES:**

Section 28 of the Act states that if a bylaw passed under section 26 or 27 decreases the economic value of the building, structure or land that is within the area designated by the bylaw, the Council shall by bylaw provide the Owner of the building, structure, or land with compensation for the decrease in economic value.

This could result in the Town of Eckville being legally required to pay compensation to the owners of Eckville's First Hospital, if it is determined that by designating the property as a "municipal historical resource, the economic value of the property was lowered or decreased.



4. NAME OF HISTORIC PLACE  
This historic place is Eckville's first hospital, located at 5204-52 St. Eckville Alberta. TOM OXO.  
Legal Description, See attached Title # 992 359 455 Exhibit "A"  
EDHS is the equitable owner of the property. The registered owner of the property has donated the house and property to EDHS as provided in the attached Donation Agreement. Exhibit "B".
  
5. WHY THIS PLACE SHOULD BE A MUNICIPAL HISTORIC RESOURCE.  
This is Eckville's last remaining and one of the oldest unaltered buildings with a significant historical connection to Eckville's past. This building is now 101 years old and represents the struggles and efforts that Eckville's early residents went through in attempting to secure proper medical facilities for the Town and surrounding Districts. This building was constructed by Dr. Backus in 1921 as a family home and an office for his medical practice. Patients attended the residence/office for examinations, treatment and some minor surgery. Dr. Backus sold his practice to Dr. Somerville in 1924. In 1931 Dr. Sommerville sold the practice to Dr. Claxton. Dr. Schreiber followed Dr. Claxton who was followed by Dr. Palmer. Dr. Palmer changed the house from a residence/medical office into a dedicated hospital. The dining room became the operating room and the 4 upstairs bedrooms became recovery and maternity wards. Financial difficulties forced the hospital to close in the spring of 1938. Dr. Frank Coppock arrived in Eckville in the fall of 1938 and opened the hospital once again. Dr. Coppock's dynamic and energetic practice of medicine and his participation in the community is a legacy that must be preserved. This building is a symbol of Dr. Coppock's dedication to the practice of rural medicine in Alberta and his devotion to the people of Eckville and surrounding area. Dr. Coppock was noted as the top notch rural general practitioner in Alberta. A young doctor, Dr. Ben Dlin sought out Dr. Coppock and came to Eckville to gain experience in practicing medicine in rural Alberta. As a result of his experiences working with Dr. Coppock he wrote a book called "Country Doctor a Memior". The book is an excellent account of rural doctoring and a glowing tribute to Dr. Frank Coppock, the man and his dedication to striving toward a high quality of medical practice in rural Alberta. When Dr. Coppock died in 1953 he was the President of the Alberta college of

Physicians and Surgeons. See " TO THE MEMORY of DR. FRANK COPPOCK"  
Exhibit "C".

6. The Applicant intends to develop the house and property into a museum or a heritage cultural center which will firstly pay tribute to rural medicine in Alberta and secondly a tribute to Dr.Coppock's dedication to the practice of medicine and his devotion to the people of Eckville and Districts.
7. The house is essentially as it was constructed in 1921. There have been no additions or structural changes to the house. The house is structurally sound for a 101 year old house. Inside, the house is basically as it was built in 1921. All woodwork and trim and walls are in good condition. The basement walls appear to be in good condition with no major cracks in the concrete. The front porch is sagging and will need shoring up. Some of the original siding is showing signs of rot but most are in remarkable good condition for 101 year old shingles. All restoration costs, upgrading will be the responsibility of the Applicant.
8. No compensation will be requited as a result of the rezoning as the Applicant has requested the rezoning and the Donor has consented to this application.
9. Should the property not be designated as a Municipal Historic Resource the present zoning prevents the Applicant from developing a museum on the sight. Without designation the house will revert to the Donor and in all likelihood the property will be sold. Without designation Eckville's last historical building and the opportunity to develop a lasting tribute to Eckville's history will be lost.

"SO LONG DOC"

A host of friends, acquaintances, patients and business associates, not only within this district but throughout the Province and the Dominion to some extent shared in the grief which shrouded the Christmas Season for Dr. Frank Coppock's family this year.

"The Old Doc" or just the "Doc" as he was known to most of us, through the many years of service to his neighbors, had become an integral part of their lives. Rich or poor, old or young, native born or newcomer, they were one and the same to him - people in need of help. From personal experience he knew the strain of long hours of physical labor, the absence of material wealth, the struggle for success, the brutality of war and the suffering of pain - and from this knowledge he gave as was needed. His was a dedicated life, personal gain counted little compared to the satisfaction he obtained from doing his job well and the best way he knew how.

True to the finest concepts of the traditional "country doctor" Dr. Coppock was yet not content to coast along on his reputation. To the best of his ability he kept abreast of the latest advances in medical science and this knowledge was placed at the service of his patients. Death was his greatest enemy and he fought it tenaciously on behalf of those in his charge yet, when his personal fight was lost, he met it calmly. Maternity cases were his specialty and the wonder of birth remained to him as fresh and miraculous as it had been in his earliest days.

Mere words cannot in themselves picture the man who was "our doctor" - his many, many contributions to the community, materially through the modern office, the hospital, the nurses residence, the "ambulance" service and his yet unfulfilled dream - the old folks home; or his personal contributions of self through his skill as a physician and advisor, his service in community organizations, his active, earnest support of anything which stood for a better community and better living conditions of its residents.

It is indicative of Dr. Coppock that he died as he had lived—in the service of his fellow man. It is fitting that as the good doctor passed away in the hospital which was his dream, a new baby uttered its first cry.

We do not find it easy to say "goodbye" to such a man as Dr. Frank Coppock because, by virtue of his innumerable contributions to the general well-being of the community, he has become to all of us not an individual but rather as institution, as ageless as the process of life itself.

No, we cannot say "goodbye" to someone who will always be with us in so many ways. Instead, let us just say, "So long, Doc. Rest in peace, assured that you will always live on in the hearts of those you served so well".

# REGIONAL NEWS

## RMH HEALTH CARE CENTRE



Alberta's government is investing \$10-million to expand access to surgeries at the Rocky Mountain House Health Centre. This investment will build a new operating room to support the surgical program and upgrade the Medical Device Reprocessing department, providing better access to surgeries close to home as part of Alberta's Recovery Plan. This construction is also part of the Alberta Surgical Initiative, which aims to provide surgeries to all patients within wait times recommended by medical experts. Investments like this one will make sure that the facility can deliver safe, efficient surgical care for years to come while reducing pressure on sites such as the Red Deer Regional Hospital Centre.

## RED DEER REGIONAL HOSPITAL



Central Albertans need better access to regional hospital services. That's why Alberta's government is investing \$1.8 billion for the redevelopment and expansion of the Red Deer Regional Hospital Centre, starting with \$193 million over the next three years. This hospital expansion is the largest in Alberta's history and the largest public investment in the history of Central Alberta. This expansion will add 200 new in-patient beds, three new operating rooms and a new cardiac catheterization lab. This is another part of Alberta's government strategy to increase health care capacity in the province.

## TRANSPORTATION UPGRADES



Alberta's Recovery Plan means continuing investments into job-creating infrastructure upgrades, like the \$120 million committed for the twinning of Highway 11 from Red Deer West to Rocky Mountain House. Albertans expect safe and efficient roads and bridges for their daily needs. Investments were made for resurfacing projects on Highway 12, Highway 13, Highway 22, and Highway 584, as well as the culvert replacement on highway 11 near Condor and replacement of the sewer system along Highway 20A in the Town of Rimbey. Alberta is investing in critical infrastructure projects now that will lay the foundation for thousands of good-paying private-sector jobs and create spin-off benefits for Alberta tomorrow.

## CENTRAL AB CHILD ADVOCACY CENTRE

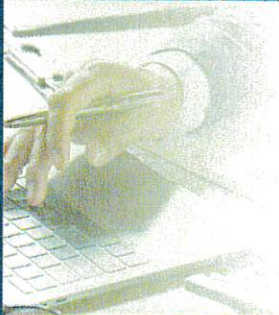

Children everywhere should have world-class support through traumatic events and abuse. That's why Alberta's government is investing \$3.9 million to the Central Alberta Child Advocacy Centre (CACAC) to expand accessibility for youth to essential services to protect their well-being. The CACAC will help protect children and youth in Central Alberta while also providing on-the-job training for students at Red Deer Polytechnic studying fields like childcare and child-welfare. On top of staff employed directly by the Centre Alberta Health Services medical professionals, law enforcement and child welfare workers will all be housed in this facility. The Centre will provide counselling to children who have been abused and help prevent abuse from happening to others. This project will protect kids and save lives.

**BY-LAW NUMBER TWELVE.**

Being a By law of the Village of Eckville to regulate the the construction of within the limits of the Village and to insure adequate fire protection.

The Council of the Village of Eckville enacts as follows :-

- (1) No building within the limits of the Village shall be equipped with metal chimneys.
- (2) All chimneys within the limits of the Village shall be of standard brick and mortar construction.
- (3) When the chimney extends through the peak of the building same shall be not less than two feet high.
- (4) When the chimney extends through the side of the building other than the peak of the roof same shall be not less than five feet high from roof.
- (5) When chimney extends through a flat roof same shall be not less than three feet high from roof.

DONE AND PASSED in Council assembled at the Village of Eckville this first day of June A.D. 1922.

A BY-LAW OF THE TOWN OF ECKVILLE IN THE PROVINCE OF ALBERTA TO ALLOW CERTAIN PUBLIC GAMES, CONTESTS OR SPORTS AT WHICH A FEE MAY BE CHARGED.

Whereas, the Alberta Lord's Day Act, being Chapter 51 of the Statutes of Alberta, 1966 was assented to on April 15th, 1966 and allows the Council of a municipality to permit certain Sunday Sports between half past one and six o'clock on a Sunday afternoon provided such by-law does not authorize the holding of or the providing of, engaging in, or attending at horse races or horse race meetings, dog races, boxing contests or exhibitions or wrestling or other like contests or exhibitions on Sunday.


NOW THEREFORE THE COUNCIL OF THE TOWN OF ECKVILLE IN COUNCIL DULY ASSEMBLED HEREBY ENACTS AS FOLLOWS :

1. This By-Law may be cited as the "Sunday Commercial Sports " By-Law.
2. Section 3 of the Alberta Lord's Day Act, being Chapter 51 of the Statutes of Alberta, 1966, is hereby declared to be in force in the Town of Eckville.
3. The public games, contests, or sports to which this by-law applies are :  
 Archery, Badminton, Baseball, Bowling, Car Racing, Car Shows, Curling, Fast Football, Football, Golf, Gymkanas, Handball, Highland Games, Hockey, Horse Shows, Motorcycle Racing, Rifle and Pistol Shooting, Rodeos, Rugger, Skating, Soccer, Softball, Swimming and Diving, Tennis, Track and Field, Trapshooting, Volleyball, Water Polo.
4. The provisions of the foregoing paragraph 3 shall not be construed so as to authorize the holding of or the providing of, engaging in or attending st, horse races, horse race meetings, dog races, boxing contests, or exhibitions of wrestling or other like contests or exhibitions on Sundays,
5. This By-law shall come into force and effect on the date of the final passing thereof.
